SUBJECT: MANAGEMENT

1. PURPOSE. This Directive provides detailed requirements for Oak Ridge Office (ORO) activities under 410 Series, MANAGEMENT, by assigning responsibility and accountability and providing administrative and/or contractual guidance to ORO and their contractors.
