SUBJECT: LIFE CYCLE FACILITY OPERATIONS

1. PURPOSE. This Order provides implementation details for the Oak Ridge Operations (ORO) activities under Series 430, Life Cycle Facility Operations, by assigning responsibility and accountability and providing administrative and/or contractual guidance to ORO and its contractors.
2. SIGNIFICANT CHANGES. This Order incorporates as Chapters in the 430 Series the current Oak Ridge Implementation Guidance (ORIG) directives and OR Orders identified in paragraph 3 below.
3. SUMMARY.
 - a. This revision to ORO Order 430 transmits the following new chapter:

Chapter I, LIFE CYCLE ASSET MANAGEMENT, which cancels and replaces:

 - (1) ORIG 4320.1A, SITE DEVELOPMENT PLANNING, dated April 27, 1992.
 - (2) ORIG 4320.2, CAPITAL ASSET MANAGEMENT PROCESS (CAMP), dated March 22, 1995.
 - (3) ORIG 4330.4C, MAINTENANCE MANAGEMENT PROGRAM, dated November 10, 1994.
 - (4) ORIG 4700.1, PROJECT MANAGEMENT SYSTEM, dated April 17, 1992.
 - (5) ORIG 5700.2D, COST ESTIMATING, ANALYSIS, AND STANDARDIZATION, dated July 19, 1993.
 - (6) ORIG 6430.1B, GENERAL DESIGN CRITERIA, dated September 2, 1993.
 - b. The following chapters, previously issued, remain in effect:
 - (1) Chapter II, IN-HOUSE ENERGY MANAGEMENT, which canceled and replaced ORIG 4330.2D, same title, dated June 1, 1994.
 - (2) Chapter III, NUCLEAR REACTOR SAFETY DESIGN CRITERIA, which canceled and replaced ORIG 5480.30, same title, dated July 27, 1994.
 - (3) Chapter IV, RADIOACTIVE WASTE MANAGEMENT, which canceled and replaced ORIG 5820.2B, same title, dated July 14, 1994.
