

**Oak Ridge National Laboratory Site Access
Requirements for Nonemployees
August 5, 2022**

For your upcoming visit to ORNL you will need to be aware of the ORNL COVID-19 vaccination policy.

Nonemployees including facility users, students, and other visitors to campus are required to be fully vaccinated (at least 2 weeks following 2 doses of Moderna or Pfizer, or 2 weeks following 1 dose of Johnson & Johnson vaccine) and complete the attached Vaccination Certification to work on site.

If not fully vaccinated, visitors must provide a negative COVID-19 test within the prior 72 hours and be tested weekly as appropriate and provide results to the ORNL Visitor Center. The test must be from a testing center that produces a result that is time/date stamped. If fully vaccinated, complete the Vaccination Certification.

Please complete the Vaccination Certification form and present it to the Visitor Center staff when you arrive. Keep the certification with you while on campus; access will be denied without it. Copies of the form are also available at the ORNL Visitor Center.

Individuals are considered "fully vaccinated" two weeks after completing the second dose of a two-dose COVID-19 vaccine (e.g., Pfizer or Moderna) or two weeks after receiving a single dose of a one-dose vaccine (e.g., Johnson & Johnson/Janssen).

I am "up-to-date" with my vaccination(s).

Individuals are considered "up-to-date" if they have received all recommended COVID-19 vaccines, including a booster dose when eligible.

I have not been vaccinated, I am partially vaccinated, or I do not wish to disclose vaccination status. If you are not fully vaccinated or if you do not wish to disclose your vaccination status, you will be treated as "not fully vaccinated."

I understand that if I make a knowing and willful false statement ORNL reserves the right to restrict my access to ORNL, including potential permanent restrictions, and to pursue any and all legal remedies available to it.

Authority: We are authorized to collect the information requested on this form pursuant to direction from the Department of Energy and applicable law.

Purpose: This information is being collected and maintained to promote the safety of Federal facilities, their workforces and others who require access to Federal facilities.

Providing this information is voluntary. However, if you fail to provide this information, you will be treated as if you are unvaccinated and may be required to provide negative COVID-19 test results at least every 7 days to gain and maintain access to the site.

Compliance with other ORNL COVID-19 safety controls: All individuals entering the ORNL site are expected to comply with mandatory site COVID-19 Safety controls, which may include the wearing of face covers, physical distancing, frequent hand washing, and other controls as directed by Laboratory personnel.
