- o 202 proposals were received May 4; peer reviews and decisions complete
- o 133 proposals approved (66%), includes 4 that were also awarded neutron time as part of CNMS project
- o Discussed issue of missing reviews, especially in cases of divergent opinions
 - Suggestion to pilot a "stand-by" reviewer arrangement in next proposal call
- o Project Extension requests for 2015B projects- deadline 6/29: 48 received of 117 eligible (41%); 25 approved with 23 still in review; approvals include 5 partial approvals where request exceeded original project scope
